PRIMARY COLOR LOGO

The Kelso logo/wordmark may be used as large as require, as it has been provided in an EPS vector format which allows it to be enlarged to any format. This includes building signage and way finding systems, truck signage, banner and billboards for various advertising and marketing applications.

LOGO CONSTRUCTION GEOMETRICS

A minimum clear space equal to the height of the Kelso logo should be maintained around the bottom edge and sides of the logo.

To maintain readability, the logo can only be reproduced to a minimum size of 1.5 inches wide.


